Dear Friends of Clelian Heights,



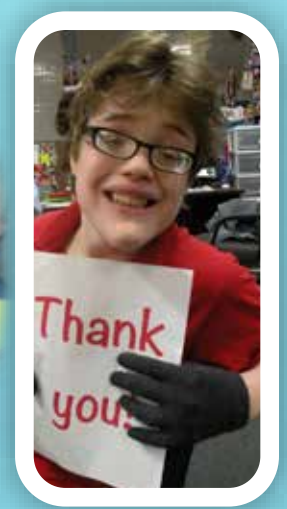
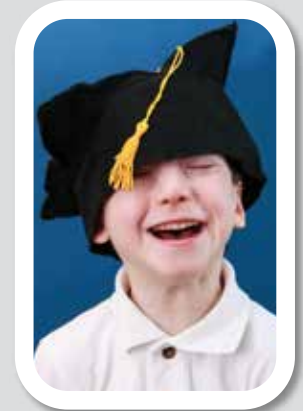
