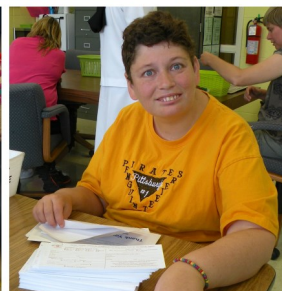

Through your generosity of gifts, grants, and support of fund-raising events during 2014-2015, we were able to improve our educational and training programs as well as complete many large and small projects that improve the facilities and span all programs. These are some of the major projects that your gifts have helped make possible in 2014-2015:

1. White boards were added to all classrooms.
2. The intercom/telephone system was replaced.
3. Security blackout blinds were added to all rooms.
4. Four additional I-pads and apps were purchased.
5. Seven computers and 2 printers were replaced.

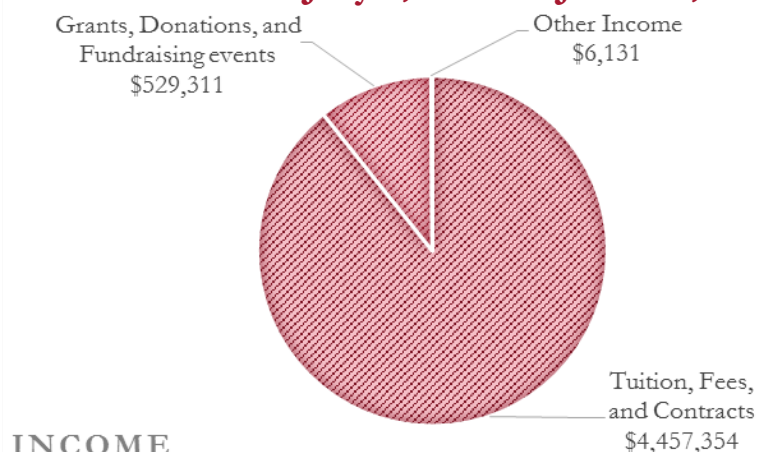

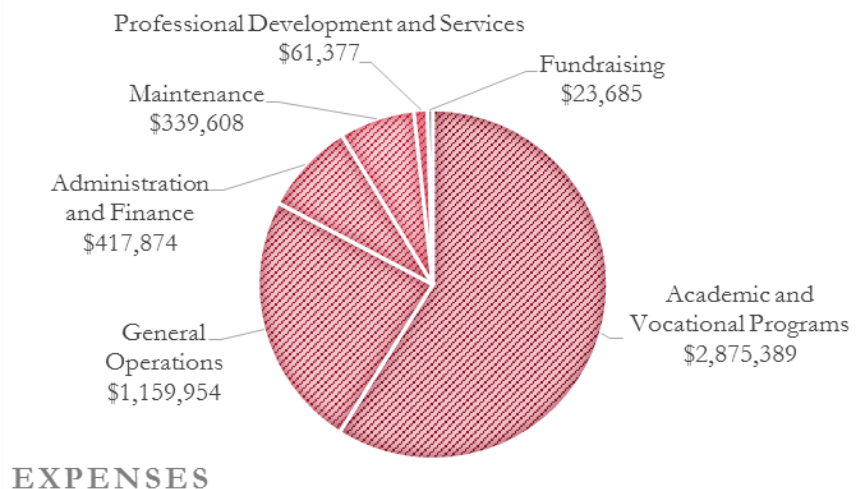

Fiscal Year July 1, 2014 to June 30, 2015



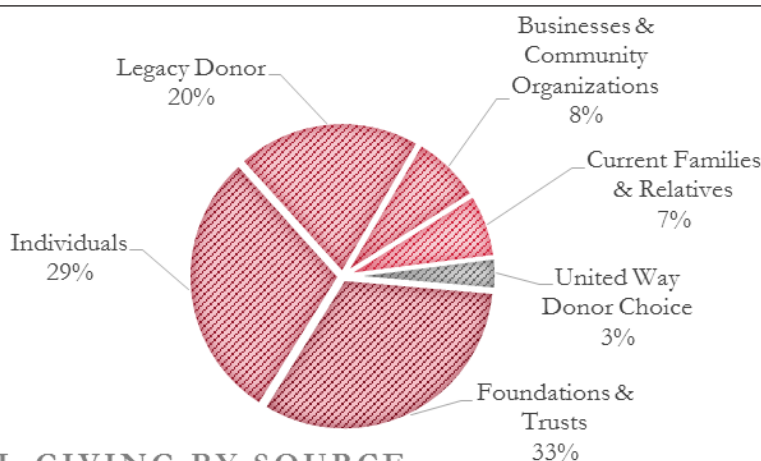
INCOME
