

Donor Advised Funds—DAFs

Have you heard about **Donor Advised Funds**, also known as **DAFs**? Many donors are setting up **DAFs**, allowing them to make charitable gifts to nonprofit organizations. A **DAF** is essentially your "giving account" established with a public charity, allowing you to receive an immediate tax deduction and to recommend grants (charitable donations) from the fund.



How does it work?

- 1) First, you open an account with a financial institution that has a DAF program (such as Fidelity or Charles Schwab). You may contribute cash, investments or appreciated assets. 2) Second, invest your assets with the help of your investment provider.
- 3) Third, recommend grants to a recognized 501(c)3 charitable organization, such as Clelian Heights Inc.

Why is a DAF a good idea? Having a Donor Advised Fund allows you to be intentional about your charitable giving. The money is already set aside for the purpose of giving it away and making a difference in the lives of others.

Thank you for the generous support you already share with *Clelian Heights*. When you make a gift to us, you directly impact the lives of children and adults with developmental disabilities and their families now, and into the future.



The good that you do for us when added up and put together—overwhelms us! **Thank You!!**

This year we undertook four projects: 1) extensive roof replacement; 2) reconfiguration of the 2nd floor school area; 3) addition of fencing to a section of the property border;
4) asphalt patching and sealing of the inner-court bicycle and walking path.



- 1) The roofing project included roof replacement over the classroom areas, part of the Clelian Center area and the pool ramp area—over 22,000 square foot of roofing was replaced.
- 2) The re-configuration of the second floor school area allows for: a) wider door entryways to provide easier mobility for those using walkers and wheelchairs, b) upgrading of electrical, c) lighting replacement, d) expansion of the Transition-to-Work program to include a Café, e) the addition of three administrative offices and a classroom for individual instruction.
- 3) The border fencing and 4) The bicycle path patching and sealing assure added safety.


